Article 15-A provides contract dollar value thresholds for purchases of commodities/services greater than \$25,000, and for construction contracts greater than \$100,000 (See also the definition of "State Contract" in § 310(13) of Article 15-A). Procurements that meet or exceed the minimum thresholds MUST be assessed for MWBE goals.
